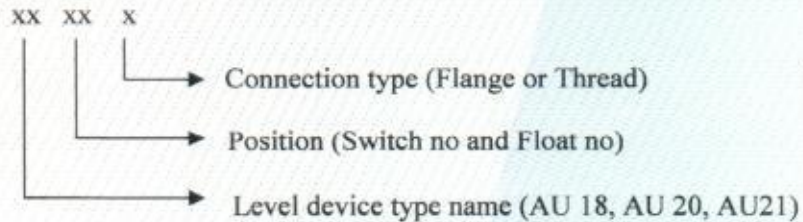
These equipments consist of mechanical and electrical parts. AU 18, AU 20 and AU 21 type level device power connection box has protection Ex d type. AU 18, AU 20 and AU 21 type level device works according to physical principles that are buoyancy force, pull and push force of electromagnetic. Magnets which are fixed to the float affect the switches and produce signal according to switches on/off positions. AU 18, AU 20 and AU 21 Level sensor device IP protection is IP 68. AU 18, AU 20 and AU 21 type magnetic level device is used for IIC gas group. Devices are assembly out of the tank. AU 18, AU 20 and AU 21 type magnetic level device is equipped with cable to use of external grounding cable 4 mm² (min) and HD 21.13.S1/HD.22.4.S4.
